Packing:

The cargo is packed into blue plastic drums, total 50 drums.

#### Sampling:

50 drums were selected for sampling by long glass pipe, total 2x500ml samples were obtained. The drum's lid was sealed by SGS logo adhesive tape after sampling.

The obtained samples were sent to SGS lab for testing and following result was obtained based on testing.






